Minutes of the Board of Directors' Meeting December 12, 2024

CALL TO ORDER

The Board of Directors' Meeting of the Erie County Gaming Revenue Authority was held on November 21, 2024 in the Board Room; 5240 Knowledge Parkway; Erie, PA 16510. Legal Notice of the meeting was given through an advertisement appearing in the Erie Times-News. The meeting was called to order by the Chair at 8:34 am.

ROLL CALL

Mr. Cleaver, Ms. Hess, Mr. Oberlander, and Mr. Winschel are present in person. Ms. Amatangelo and Mr. Barney are present via zoom. Mr. Scutella is present in person. Mr. Sinnott and Mr. Copeland are present via zoom. Mr. Wachter and Dr. Wood are present in person.

APPROVAL OF THE AGENDA

Mr. Winschel makes a motion to approve the agenda. Mr. Oberlander seconds the motion. There is no discussion of the agenda. Motion carries 6-0.

APPROVAL OF MINUTES - November 2024

Ms. Hess makes a motion to approve the minutes. Mr. Oberlander seconds the motion. There is no discussion on the minutes. Motion carries 6-0.

DIRECTOR'S COMMENTS

There are no comments at this time.

COMMENTS BY THE CHAIR

Mr. Cleaver has no comment at this time.

PUBLIC COMMENT

There is no one from the public present.

PRESENTATIONS

There are no presentations scheduled for today.

COMMITTEE REPORTS

a. Treasurer's Report

<u>Ms. Amatangelo</u>: I'll be very brief with everyone. I had no major questions for the financials for November. I did want to just point out that if you look at the Balance Sheet, you'll see that the Erie Bank Money Market is due to be looked at this month. So, I'm sure Dr Wood will be addressing that soon. And then I did want to point out, if you look at our Grant Reserves disbursements, and you can also see it in our Transaction Detail, that the initial payment for the Fly Erie Fund did go out in November; that was \$125,000. I wanted to point that out for everyone. Otherwise, I don't believe I had any questions. So, I wanted to leave it open to the other Directors in case there were any questions to inquire about.

Mr. Barney makes a motion to approve the Treasurer's Report. Mr. Oberlander seconds the motion. There is no further discussion on the Treasurer's Report. Motion carries 6-0.

b. Strategic Planning Committee

No meeting was held, so there is nothing to discuss.

c. Update from County Council

Chairman Scutella: I have nothing to report.

d. Update from County Executive's Office

<u>Mr. Sinnott</u>: The Administration has nothing today.

REPORT OF THE EXECUTIVE DIRECTOR

<u>Dr. Wood:</u> Okay, I'll be quick on the Director's Report. You see there was a Fly Erie Fund meeting that took place on November 26; I'm the vice chair of it, so I actually chaired that meeting because the chair couldn't be there. We did discuss where we're at with Breeze, which in the Treasurer's Report that was given. I did include talking points for everyone here, so if your colleagues are asking you questions about "What is the Fly Erie Fund all about, what is it accomplishing, where is it headed?" there's some really good talking point information here for you. It's about five or six pages long. We're going to keep adding to that as time goes on and people ask new and different questions, but it'll give you a pretty good overview of where this program is and where it's headed. As of right now, we've got

the two destinations looking at third destination. I think I mentioned last month that we're looking for someone from the airport to come in and actually give an update to the Fly Erie board on the progress that is being made.

If we scroll ahead, you'll see there's some public relations, some newsletters that we were in, some letters of support that came in from various organizations, like Zabawa, for example, and then an article about the budget and the role ECGRA is playing in the budget. Now what's we'll talk about this more during Executive Session, but if you're unaware, last Friday, when Council held a veto override session, the County Executive had vetoed \$2.5 million for daycare money coming to ECGRA and Council overrode it last Friday. Then on Monday morning we got a letter from the County Executive saying that our ARPA contract was canceled, and we needed to return all the funds available. So that's why I have these four letters here in front of you. But we'll talk about that more in the Executive Session.

Any there any questions for me?

<u>Mr. Cleaver</u>: I have one quick comment in reference to the airport. I noticed that they're having a huge special on Facebook. I see that with \$239 and you can fly free for X number of flights. It's really a good deal if you're a Tampa or Orlando flyer; the price is right. I just happened to catch that on Facebook a couple of days ago. I think it's like \$239 - that's the special. Then I see they have the credit cards out, which is you get a return on your credit card for mileage. So, they're moving forward, I've been so attracted because I have a lot of people that contact me that travel that want to know what's happening. I just thought I'd mention that for the record.

Are there any questions in reference to the Executive Director's Report?

SOLICITOR'S REPORT

<u>Mr. Wachter</u>: I would ask that we go into Executive Session for the purpose of receiving confidential legal advice.

Mr. Cleaver: I have a question here.

Mr. Wachter: Yes, sir.

<u>Mr. Cleave</u>r: We know what direction, in reference to the letters we received over the week here, we know what direction County Council is requesting they are going. We also know what direction the County Executive is going. My question to you is, can we have an Executive Session without the liaisons, which I think, in my opinion, is an advantage to speak a little bit more freely. And I guess I have two questions - can we do that legally? and does the Board want to do that?

<u>Mr. Wachter</u>: Legally in this situation, because the entity with which there is a potential legal conflict, would be the County Executive's office, it would be appropriate to have the conversation without the presence of the County Executive's representative in that Executive Session.

<u>Mr. Sinnott</u>: And I'll be happy to leave whenever you guys say it's appropriate. I have no problem with that at all.

<u>Dr. Wood</u>: So, if we're going to go into Executive Session, we'll ask Mr. Sinnott, we'll put you in the lobby, in the Zoom meeting, and as soon as the session's over, sir, we'll bring you back.

Mr. Sinnott: Okay.

Dr. Wood: Thank you, sir.

<u>Mr. Wachter</u>: We'll put Mr. Rao in that same lobby, as much as he would like to know our session, I think that is not appropriate.

<u>Mr. Cleaver:</u> Terry, we're going to have to ask you go sit by the fireplace and have a cup of coffee.

Mr. Scutella: Okay, I have no problem with that.

Mr. Wachter: Would you like Mr. Copeland to go as well?

Mr. Copeland: Yeah, throw me in the waiting room. That's fine.

Mr. Winschel: County Council, they don't need to go. I mean, unless you want them to.

<u>Mr. Cleaver</u>: Well, I just think that we know their stand, and I just felt everybody would be a little bit more relaxed, because of the County Council has appointed one of us for something. It's sort of just in between, I think it'd be better for all concerned, just you can speak to peace, and hopefully it stays within the range of all of us.

Mr. Winschel: Okay. Understood.

<u>Mr. Wachter</u>: That went better than the day I threw Fiore Leone out.

Executive Session begins at 8:43 am and ends at 9:28 am.

Mr. Wachter: By the unanimous consensus of the Erie County Gaming Revenue Authority's board members, my office has been authorized to file an Action in Mandamus and appropriate injunction if necessary in the Erie County Court of Common Pleas to ensure that the County proceeds with its ministerial obligation to contract with the Erie County Gaming Revenue Authority to fulfill the will of Erie County Council's appropriation of the \$2.5 million to provide funding for the childcare initiative to alleviate the childcare crisis that is occurring in Erie County. There is a concern that the correspondence from the County Executive that was sent yesterday and as well as the correspondence from Monday are not only inaccurate in that the Erie County Gaming Revenue Authority is not out of compliance with the US Treasury reporting requirements, that the County has accepted all of the reports that we have filed well over a month and a half ago without any comment, and that the additional conditions that are placed in the correspondence by the Erie County Executive as preconditions to contracting with the Gaming Authority for the \$2.5 million are neither required by the federal regulations nor the contract with Erie County on the prior appropriation. Specifically, meaning that in the County Executive's condition that his office has the independent authority to look at and review and retroactively approve or disapprove any grant allocation that has been made by the Erie County Gaming Revenue Authority is not within his purview, either under federal regulations, or the Erie County Home Rule Charter.

Additionally, the Erie County Gaming Revenue Authority is of the opinion that the Erie County Executive does not have the unilateral authority to terminate the agreement by convenience. I would like to note that even though it has been reported in the press that the County Executive's attempt to terminate the contract with the Erie County Gaming Revenue Authority was due to some noncompliance by the Erie County Gaming Revenue Authority, that is not what the County Executive did, that is political spin. The County Executive attempted to terminate the contract by convenience,

which is a provision of the contract that was required to be in the contract by the federal ARPA regulations. However, that money was appropriated by Erie County Council without precondition with the specific intention that the Erie County Gaming Revenue Authority utilize those funds for the purposes for which it was appropriated and as such the County Executive's office does not have independent unilateral authority to terminate that agreement, as to allow for that to occur would be to frustrate the specific appropriation made by Erie County Council and violates the spirit and likely also the letter of the Erie County Home Rule Charter and the separation of powers doctrine that is incorporated therein.

So, we will be responding with a correspondence to the County Executive from the Chairman indicating as such and then preparing the necessary Action of Mandamus and Emergency Injunction accordingly.

Why, you may ask, is there such urgency associated with this and that is because the federal regulations governing the American Rescue Plan Act dollars which are at issue here and not only the \$392,000 that is remaining from the \$4 million appropriation as well as the \$2.5 million appropriation that just recently occurred and the County Executive has made it clear as to his will of that \$2.5 million as he attempted to veto it and the veto was overridden, but the federal regulations that are associated with that require that if the money is not obligated by the County by December 31, 2024, then the money has to be returned to the United States Department of the Treasury. And in Erie County, according to the Home Rule Charter, the money may not be obligated until County Council appropriates it and the County Executive's office then executes on that will of County Council through the provision of a contract to implement that appropriation. So, even if that \$392,000 was appropriately terminated and was to go back to the Erie County Executive, if that \$2.5 million is not fulfilled and the appropriation be executed here to the Erie County Gaming Revenue Authority, in order for that money to be obligated, it would have to be reappropriated by Erie County Council. So, the County Executive does not have that independent authority to determine under which line item that money would go.

Therefore, this board has expressed its concern for the taxpayers and the residents of Erie County in wanting to ensure that this money does not get caught up in a situation where it was returned to the United States Department of the Treasury and has directed my office as Solicitor to take the necessary steps to ensure that the will of County Council be fulfilled, that the money be protected for the residents and citizens of Erie County, and that this appropriation be fulfilled as designed by Erie County Council.

Is that an appropriate summary of the discussion that was had?

Mr. Cleaver: Excellent.

Ms. Hess: Absolutely, yes.

Mr. Winschel: Yes.

Mr. Oberlander: Yes.

Mr. Barney: That was well put.

Ms. Amatangelo: I agree.

<u>Chairman Scutella</u>: For the will of the people of Erie County, that's the last thing you would want to lose is, not just this money, but I think it's up to \$8 million that the people of Erie County would lose, just because of the petty fights between the Administration and County Council.

Mr. Wachter: I have nothing further, Mr. Chairman.

OLD BUSINESS

a. Erie Bank Money Market Fund

<u>Dr. Wood</u>: I just wanted to briefly tell you that today is the day the Erie Bank Money Market fund percentage is going to be lowered, at least that's the indication. We don't know what it's going to be lowered to; Erie Bank hasn't gotten back to us. We tried a couple of times to reach out. So, we have no designation for those funds as of right now.

Mr. Cleaver: What's the percentage rate presently?

Ms. Michali: 5.3%.

<u>Dr. Wood</u>: 5.3%, thank you. And we think it's going to go down to at least, we think 4.75%. But we're going to shop around to a couple of places before we make any decisions. Are there any questions about the Money Market?

Mr. Cleaver: Are there any questions in reference to that Money Market?

<u>Mr. Winschel</u>: Perry, I just ask that when you get a rate, see if you can lock that in for a period of time like you did last time. Last time they guaranteed that for three or four months. I think there might be better rates in the next week or two so if you can get them to commit to locking in the rates.

Dr. Wood: Yes, I'll look at three to five months for that.

Mr. Winschel: That would be great, thanks.

NEW BUSINESS

a. Resolution Number 27, 2024 – Resolution to Direct the Erie Community Foundation to Release \$594,154 to the Erie County Lead Assets

<u>Dr. Wood</u>: Every year in November or December, we receive a notification from the Community Foundation saying, "Here is the money available to be distributed via the Lead Asset Endowment." That number then goes to the Lead Assets themselves who meet as a committee, and they come back to us with this document that says they have all come to consensus and this is how they want the funds divided up. I then bring it back to the Board for any questions that you might have. This process has been going on for seven or eight years now. It is governed by a legal memo that we have with the Lead Assets. Are there any questions about this number or how we got to this point?

Dr. Wood reads the resolution.

Ms. Hess makes a motion to accept the resolution. Mr. Barney seconds the motion. There is no discussion of the resolution. Motion carries 6-0.

ADJOURNMENT

<u>Mr. Cleaver</u>: Before we adjourn, I want to thank everyone for a great year. Again, Dale, we're going to miss you. Be safe wherever you go. Merry Christmas and a Happy New Year to all.

<u>Mr. Barney</u>: I'd like to wish everyone a Merry Christmas and Happy Holidays and Happy Hanukkah and everything and just stay safe.

County Executive Davis facing another lawsuit

Erie County Executive Brenton Davis has been a frequent critic of the county's Gaming Revenue Authority and Diverse Erie commission.

But a recent directive by Davis has taken that criticism to another level, with some county and legal officials calling the action a blatant violation of the separation of powers.

Here's what to know.

Davis demands return of ARP funds

Earlier this week, Davis sent letters to ECGRA and Diverse Erie, urging them to return their unspent pandemic-era American Rescue Blan money to the county by Monday.

ECGRA and Diverse Erie entered into ARP agreements with the county in 2021 and received \$4 million and \$3.5 million in ARP funds, respectively.

Both used the funds to help communities bounce back from the COVID-19 pandemic, awarding grants to minority- owned small businesses, nonprofits and community facilities, among others.

The two entities have just under

\$400,000 remaining in unspent ARP funds.

Davis said he wants that money back and cited a clause in the ARP grantee agreement that states the county can terminate the agreement "for convenience," and require all unspent or unawarded funds to be returned.

A "convenience" clause is a contractual provision that allows one party to end a contract without cause or penalty.

Erie County Public Information Officer Chris Carroll said the administration intends to use the returned funds to support disaster relief efforts related to the recent lake-effect snow disaster.

Carroll said the decision to reclaim the ARP funds was motivated by "serious concerns" about transparency, accountability and the proper management of public funds by ECGRA and Diverse Erie.

"The county taxpayer is ultimately responsible for repaying the U.S. Treasury if these funds are misspent," he said. "It is our intention to protect the taxpayer and recall this money so that we can reduce any further risk."

Diverse Erie Chief Administrative Officer Gary Lee declined to comment on the matter before speaking with the commission board and solicitor.

The ECGRA board, however, is preparing to sue the administration.

ECGRA solicitor to file lawsuit, says Davis claims are 'inaccurate'

Erie County Council recently approved an additional \$2.5 million in ARP funds to ECGRA to address the county's childcare crisis. Davis vetoed the line item — he didn't want ECGRA to administer the funds — but council overrode the veto on Dec. 6.

Despite the approval, Davis has refrained from negotiating a new ARP grant agreement with ECGRA, claiming ECGRA is still not compliant with U.S. Treasury reporting requirements for its initial \$4 million ARP allocation.

In a letter sent Wednesday to the ECGRA board, Davis laid out three "conditions" that would allow for a new ARP grant agreement: Firstly, ECGRA must provide a complete report of all expenditures related to the \$4 million; the county must then review and approve it to confirm compliance; and finally, ECGRA must abide by the grant termination notice and return any remaining funds to the county by Monday. Until those conditions are met, the county "cannot, in good conscience, negotiate a new grant agreement," Davis said regarding the additional \$2.5 million.

ECGRA Solicitor Tim Wachter argued that contracting with an entity is a "ministerial duty" for the county executive and that once Erie County Council appropriates money to an entity, the executive is "obligated to go make it happen."

Wachter said Davis' "conditions" were not equired by federal regulations or the initial ARP contract and were merely an additional way for him to "frustrate the power" of Erie County Council.

As such, the ECGRA board on Thursday unanimously agreed to authorize Wachter to file a lawsuit against the county in the Erie County Court of Common Pleas. The lawsuit, a mandamus action, seeks to ensure the county performs its ministerial obligation to contract with ECGRA and fulfil council's appropriation of the \$2.5 million.

Wachter also noted that Davis does not have the "independent unilateral authority" to terminate an agreement because Erie County Council appropriated the ARP money for a specific purpose.

"To allow for that to occur would be to frustrate the specific appropriation made by Erie County Council," Wachter said. "It violates the spirit and likely also the letter of the Erie County Home Rule Charter and the separation of powers doctrine that is incorporated therein."

Council Councilman Rock Copeland, who serves as finance committee chairman, echoed Wachter.

"Brenton Davis' illegal defiance of council's authority through bureaucratic obstruction violates his oath and the Home Rule Charter, "he said. "This demands immediate legal action."

Wachter further said Davis' correspondence was "inaccurate" and stressed that ECGRA was compliant with U.S. Treasury reporting guidelines. He added that the administration hasn't provided any evidence that ECGRA is out of compliance.

Administration calls out Diverse Erie

Much of the administration's evidence deals with Diverse Erie.

Carroll provided email correspondence to the Erie Times-News, revealing how three small businesses that received grants from Diverse Erie in July 2023 had not responded to requests for expense documentation, as of November.

Carroll also showed a Nov. 15 email from Lee in which he stated that the remaining fund balance of Diverse Erie is "fully committed to the commission's operating budget."

"The administration will not allow nearly half a million dollars to sit idle, covering salaries and rent, without any efforts being made to establish new grant programs or deliver meaningful impact," Carroll said.

"The call to return the money is the necessary step to rectify these problems and ensure ARPA dollars are used as intended for the benefit of the community and in compliance with U.S. Treasury guidelines."

Davis' directive also requires Diverse Erie to scrap its pending contracts and agreements.

Erie County Council had approved an additional \$1.5 million in ARP funds to Diverse Erie. However, the administration has refused to certify the availability of those funds, placing the commission's future in limbo.

Wachter, who also serves as Diverse Erie solicitor, said he anticipates the commission, like ECGRA, to similarly push back against Davis' actions, potentially with legal action.

Why Davis wants two checks at ECGRA's check presentations

Whenever the Erie County Gaming Revenue Authority awards a series of grants, a news conference is typically held in which awardees join ECGRA and county officials behind a large ceremonial check.

But starting in 2025, when ECGRA will award \$2.5 million in grants to support child care, the public will notice a separate large check, one that will likely be held by Erie County Executive Brenton Davis, who's intent on having the county — and his administration — also get credit.

The \$2.5 million is from the county's share of federal American Rescue Plan funds and was appropriated by Erie County Council to ECGRA in November. The funds are expected to be matched by \$2.5 million in gaming funds.

During check presentations, Davis wants one check to show the ARP contribution and the other to show the gaming match. The dual checks are not a suggestion but a contractual obligation, one of many Davis injected in ECGRA's new ARP contract to ensure the

county is acknowledged.

"I think it's redundant and a little bit petty," ECGRA Executive Director Perry Wood said. "We view ourselves as in partnership with Erie County. We're an Erie County authority — it's in our name."

Wood said he's always acknowledged the county's support at previous check presentations and that the county executive has appeared at several of them.

Davis is nonetheless requiring ECGRA to acknowledge the county's support in news media interviews and in materials, advertisements, social media and mailings related to the ARP contract and grant awards. He also wants the county seal to appear on the large ARP checks.

Wood said the requirements for public acknowledgement were the most contentious part of the negotiations with the Davis administration on the ARP contract.

"We weren't too focused on those issues in the past, but we realized that the county executive's office was focused on those issues," Wood said. "At the end of the day, government is about compromise and cooperation and so we put our feelings aside and we signed the contract."

ECGRA and Davis reach compromise, avert legal showdown

The ECGRA board authorized Wood to sign off on the \$2.5 million ARP contract during a special meeting Thursday, capping a turbulent two weeks between ECGRA and Davis.

The turbulence began when Davis notified ECGRA in a Dec. 9 letter that he wouldn't entertain the new ARP contract until ECGRA returned its remaining ARP funds from a 2021 contract signed by former County Executive Kathy Dahlkemper.

Davis stated in his letter that he terminated that contract and wanted those remaining ARP funds — roughly \$330,000 — to offset snow removal costs incurred during the recent lakeeffect

snowstorm.

Davis also informed ECGRA the county had not received a complete and accurate reporting of expenditures associated with the 2021 contract. Wood told the Erie Times-News on Thursday that the administration couldn't provide any evidence ECGRA was out of compliance with ARP guidelines and that administration officials later admitted to him ECGRA was not out of compliance.

The ECGRA board subsequently authorized its solicitor on Dec. 12 to file a lawsuit against Davis, seeking a court order that would require the county executive to carry out his ministerial duty to fulfill the \$2.5 million appropriation, as approved by Erie County Gouncil.

The lawsuit was averted after ECGRA and the administration finalized a deal shortly before Thursday's meeting.

The deal involves Davis rescinding his termination of the 2021 ARP contract, contingent on ECGRA approving a grant of up to \$500,000 in gaming funds to go toward emergency snow removal costs.

The ECGRA board approved a resolution authorizing the grant Thursday.

The deal included an amendment that would extend the 2021 contract through June 30 and repurpose those funds from professional services to grant awards.

ECGRA Board Chairman Ronald Cleaver told the Erie Times-News he was satisfied with the outcome.

"This could have been resolved without going through all of this rigmarole," he said. "But it's over and done. Everybody's happy. Everybody's satisfied. We'll move on."

Erie County Public Information Officer Chris Carroll could not be immediately reached for comment Thursday.

ECGRA to support childcare facilities, staff

As part of the deal, ECGRA will also remain manager of the \$2.5 million in ARP funds for child care.

The \$2.5 million will be awarded to members of the early childhood development and daycare community throughout the county, with a focus on infrastructure and workforce development.

The grant awards will support the creation and expansion of childcare slots available through Erie County.

The Northwest Institute of Research, an Erie-based nonprofit that operates early learning centers, will make award recommendations to the ECGRA board. The board will have final and independent discretion on all award decisions, according to the contract.

"I'm ecstatic that the daycare community is going to benefit from these funds — that was our goal from Day One," Wood said. "So, whenever we got bogged down in negotiations, I just reminded myself that we were doing this for the working families of Erie County."
