#### **Erie County Gaming Revenue Authority**

Minutes of the Board of Directors' Meeting September 19, 2024

#### CALL TO ORDER

The Board of Directors' Meeting of the Erie County Gaming Revenue Authority was held on September 19, 2024 in the Board Room; 5240 Knowledge Parkway; Erie, PA 16510. Legal Notice of the meeting was given through an advertisement appearing in the Erie Times-News. The meeting was called to order by the Chair at 8:32 am.

#### **ROLL CALL**

Mr. Barney, Mr. Cleaver, Ms. Hess, Mr. Louis, Mr. Oberlander, and Mr. Winschel are present in person. Mr. Wachter and Dr. Wood are present in person. Mr. Sinnott is present via zoom (arrives late).

#### APPROVAL OF THE AGENDA

Mr. Barney makes a motion to approve the agenda. Mr. Oberlander seconds the motion. There is no discussion of the agenda. Motion carries 6-0.

#### APPROVAL OF MINUTES - August 2024

Mr. Barney makes a motion to approve the minutes. Mr. Louis seconds the motion. There is no discussion on the minutes. Motion carries 6-0.

#### **DIRECTOR'S COMMENTS**

There are no comments by the Board of Directors.

#### **COMMENTS BY THE CHAIR**

Mr. Cleaver has no comment at this time.

#### **PUBLIC COMMENT**

There is no one from the public present.

#### **PRESENTATIONS**

There are no scheduled presentations.

#### COMMITTEE REPORTS

#### a. Treasurer's Report

<u>Dr. Wood</u>: Angie is not here so I will go over the finances with you. You can see on the Profit & Loss statement that the second quarter gaming revenue came in at \$1.15M. Also, we received the monthly interest on our savings account, and then the interest payment on the eCAT investment. So those are the three forms of revenue. There's a nice summary of the expenses; we'll go into more detail in the Budget vs Actual. You'll see the grants that were disbursed, and whenever revenue comes in from gaming, there's going to be a municipal disbursement line item. The first thing you're seeing there, that's the settlement disbursements. There was a Special Events grant, a Mission Main Street Grant - that was the Downtown North East one. And that's your summary of the finances.

Flipping over to the Balance Sheet. Let's take a look and zoom in on the CDs. I want to point out that the cash deposits are now on record under Other Current Assets.

Mr. Winschel: Can I ask a question on that?

Dr. Wood: Yeah, sure.

Mr. Winschel: So, Tammi, you posted it under Current Assets. You have, like, FNB CD-6.

Ms. Michali: Yes, that's the sixth month CD.

<u>Mr. Winschel</u>: Correct. Do you have more space on there to put any more information? For example, could you put the date of maturity so as we review these each month, we could see that it's coming up?

<u>Dr. Wood</u>: Yeah, we debated that. I was going to talk about that today.

Mr. Winschel: Okay, if that's later, that's fine.

<u>Dr. Wood</u>: This is the section right here. And as Gary pointed out, FNB CD-3, that's a three month; CD-6, CD-9, the Flagship CD, and Erie FCU. The Erie FCU is in August 2025, Flagship is February 2025 so if you want to put that on there as a reminder. Do we have enough room for the number?

Ms. Michali: Yeah, we can add that.

Mr. Winschel: Just like 8/25.

Mr. Barney: That would be beneficial.

<u>Dr. Wood</u>: We just didn't want to overdo it, but it's not a problem. We can do that.

<u>Mr. Winschel</u>: That way when we see they come due we can have a discussion. Just a further comment, you know you may have seen that the Federal Reserve cut rates yesterday 50 basis points. So even this morning, I was looking at when your CDs are like 4.6 now and you locked that one in at 5.4 or 5.3%. So good timing to lock that in anticipation that the rates would be cut. So, thanks. That would be great. That'd be beneficial.

<u>Dr. Wood</u>: I appreciate you guys staying on me for that. So, in the section above is the Erie Bank Money Market and that's the other new line item in that section at just over \$6 million. Okay, so that's how we're going to present those on the Balance Sheet; we'll take Gary's suggestion into account for the next time, and we'll have a maturity date. Are there any other questions about that? It's going to be the newest thing we've done financially. There is a second page of that report as well.

Moving to the Budget vs Actual - Accounting Fees, \$1,650 that's the final payment to Maher Dussel for our 2023-2024 audit, and it always bleeds into the next fiscal year, so that's why you're seeing that number there. Moving down to Books, Subscriptions, Dues, that number of \$549 is a little higher than usual because \$538 of it was an American Planning Association membership; we purchase that membership for Tom every year to stay current on his credentials. Scrolling down to Bank Fees, you might say, "Hey, I thought we took care of those bank fees with Erie Bank." We did. That \$30 fee is for a one-time wire transfer to Erie FCU. Scrolling down to Advertising at \$478 - \$300 of that was to sponsor the Navy band at the Soldiers and Sailors Home. Outreach shows \$45 for nameplate for Mark coming on board. Scrolling down to Phone/IT/Fax at \$5,074 - \$169 of that was for zoom which is a yearly cost, our Titan membership, which is our IT membership for technical services at \$1,156 every two years. And then Board Effect, which is \$3,700 every six months.

And I think I'm going to be following up with each individual board member and talking about the technology we use. I'm going to actually talk specifically about Board Effect because Tammi and I have been discussing it; it's expensive. It does a good job for us in putting together these board packets, but we used to use it as an archive for the board members, but now everything's online; everything's on our website. So, I don't know if it makes sense for us to continue. So, when I follow up and have individual conversations with you, we'll make that part of the discussion. Farther down you'll see Contracted Services under ARPA, \$4,900 of that is the Policy Map renewal, which is the technology we use to track to make sure that we're investing in underserved markets. If you remember for the Grow Erie fund, we hired a consultant to look at Grow Erie for us to get financial projections - that was \$1,500. So, those are both reflected that way. Any questions on budget expenditures?

Mr. Oberlander: Just one quick question. What line item would it be for the signage? For example, Union City, with their signs, where would that be? I was trying to scroll down but I didn't see anything. Because we do a lot of signage, right?

Ms. Michali: Signage is under the Outreach.

Mr. Oberlander: Outreach? Okay.

<u>Dr. Wood</u>: You can see there that line items almost fully expended at 97%. Any other questions on the Budget?

All right, flipping ahead to the Grant Reserve. You're going to see there the settlement municipalities were funded. So, every time gaming revenue comes in, every quarter, instantly the settlement checks go out; there's the amounts right there. Scrolling ahead to the next page, Downtown North East is the Main Street that was drawn down on. The next page is basically blank and then the final page is the Special Event that was drawn down, which was the Greek Fest at \$7,300.

Now the second part of this report is the amount remaining. So you can see there, Downtown North East that the August drawdown was \$87,500; that means they have zero left out of the original commitment of \$175,000. Let's scroll ahead to the Check Register. All the grants that I just mentioned are in here, all the payments from our budget are in here, the settlement checks, the employee's payroll, the bank fees. Are there any questions on the Check Register?

Let's scroll ahead to the Visa. This is pretty standard - office supplies, the Zoom renewal was paid on the Visa, water and newspaper subscription.

Mr. Winchel: Perry, quick question. You have a charge for \$5,000 for Policy Map; that's the software you were talking about.

<u>Dr. Wood</u>: Yeah, Policy Map is a software. I believe they're based out of Philadelphia, the group that developed it. The State of Pennsylvania actually uses it, too. Next, you'll see the planning membership and there's some office supplies. Next, we'll look at the Amazon charges – coffee, sticky notes, and disposable lids for coffee cups. Are there any questions about any of those charges? I don't mind going into detail. Of course, this is your chance to hold us accountable for what we spend the dollars on. Thank you very much.

Mr. Winschel makes a motion to accept the Treasurer's Report. Mr. Barney seconds the motion. There is no further discussion on the Treasurer's Report. Motion carries 6-0.

#### b. Strategic Planning Committee

<u>Dr. Wood</u>: That committee met a few weeks ago and we reviewed the 10 applications for Anchor Building. The committee recommended six of the 10. Then we had an update on First Ascent and a memo was delivered answering some of the questions about First Ascent and the Gannon project. It's really a Gannon/ First Ascent/ Allegheny Health Network project. And you're going to see a resolution today for us to become a member of PLGIT. I want to remind you that it costs us nothing, but we do need to take action. We will formally be a member of PLGIT, like a Council of Governments, since that's how they're legally structured. Any questions about that committee?

Let the record reflect that Mr. Sinnott has joined the meeting via zoom.

#### c. Update from County Council

Chairman Scutella is not present to give a report.

#### d. Update from County Executive's Office

Mr. Sinnott: I'm having a little trouble with my Zoom this morning, if you'll bear with me. The Administration has nothing to report today. Thank you.

#### REPORT OF THE EXECUTIVE DIRECTOR

<u>Dr. Wood:</u> The first thing in the packet is the revised scope of the audit. So, this letter came in for the audit; this is great news because they revised the scope to include revenues as part of the audit. I think we announced that last month, but this is the official document. So now it's on record. And that is because we have some discrepancies with the County as to whether or not the appropriate amount of revenue is being received, because our records show that it is not. So, the Auditor General is going to take care of that as part of their audit. If you scroll ahead, you can see that the entire world got cc'd on that letter. Everyone in the State of Pennsylvania saw this. Let me stop there. Are there any questions about the audit that I didn't address?

Next you will see Kate & Co's list of what they have done for us this month. Then you'll see the Strategic Planning agenda. Next is an announcement that we did with the eCAT Construction Trades Pilot, which is going to be done by the BUILD and the Hamot Health Foundation. We awarded them funds and had a great announcement with Erie Insurance and the Community Foundation, in partnership, all three of us funded it - about a million-dollar project when it comes down to it. We were in for it for just over \$200,000. So, that was a great announcement, we did that down at a building in the Bayfront Eastside Taskforce neighborhood where it's going to be used as a model for the students to have actual practice.

Now to the packet in front of you. I handed this article out last time which is about the skills games and the issues around the casinos suing the State of Pennsylvania over skills games. Skills games are not taxed the same, but they basically function like a – well, there's some arguing over whether they function like a slot machine. That lawsuit is going out. The difference between last time there was a lawsuit over gaming is that the last time it was a casino suing the Commonwealth over the same clause over how they were taxed, but it was to open up the gaming law itself. This is different. This is being addressed with a seperate law, so the skills games will be addressed separately.

There's an email from Dave Kozak, who is Senator Laughlin's Chief of Staff. I went and had a meeting with him when he was in town, and we kind of went over this legislation. And here's kind of his summarization. I asked if I could give this email to the Board where he kind of summarizes. Basically, it's a separate bill, it will not affect the current gaming bill which is fantastic news for us. It will, however, address to what level these machines are taxed. We have previously taken a position on what are called VGTs, or video game terminals. Tim tells me those are technically different from skills games, but I would say our position is probably the same, which is that anything that hurts the bricks and mortar casinos where our revenue comes from, needs to be either appropriately taxed or are not allowed to come into legislation. He did assure me that this bill is not going to be considered in the current session but could be considered next year as part of a revenue bill. So, we're going to follow it, Tim and I've had a couple discussions about it, we're going to follow it with Senator Laughlin's office and see where it goes. Senator Yaw is the one proposing it; Senator Yaw does not have a casino in his footprint. He does, however, have a manufacturer of skills games in his footprint.

There is one unaddressed issue in here, and that is whether or not it's appropriate for ECGRA to advocate to be part of the revenue stream if something like this passes. So, I think that is something we should consider moving forward and have some strategic discussions on. For example, the way the current legislation for online sports gaming is written, it favors us. So, it maintains the split between the county and ECGRA. This bill doesn't address that because this Senator doesn't know anything about Erie's special situation. So, we would have to address that moving forward. Any questions about that?

Here is a summary of the bill in case you're wondering. This is a summary of the bill that we're talking about and then here's page 25 and 26 of the bill. Tim and I went over this. This is how the revenue is currently split, 50% deposited into the State's general fund, 22% distributed to individual counties proportionally based on gross profits; it says nothing about gaming revenues, I mean local share gaming revenue. Tim has the language on what would make sense for us to propose at some point to make sure that we're a piece of that legislation.

That's it for that. That's why that packet is in front of you to take that with you and digest. If you have any questions, don't hesitate to follow up with me on it. I'm going to have a conversation with you before we do anything official on that. In the past, we had to hire a lobbyist. I don't think that's necessary in this particular circumstance. But we'll keep that door open.

Moving on, there's Asbury Woods recognizing some ECGRA funding, a nice email about Celebrate Erie, a Times News story on Grow Erie, a Corry Journal article on Renaissance Block, and there is an Infinite Erie article in there. Any questions for your executive director?

#### SOLICITOR'S REPORT

Mr. Wachter: Perry allowed me to geek out a little bit on policy stuff and tax stuff and get into the legislation and that was fun. But when you're ready to discuss specific language or items that need to be addressed with that, we're ready to do that. I think Erie County is well positioned between having the Senate Policy Committee Chair and the House Policy Committee Chair being represented directly out of Erie County, that they are aware of our issues and we will make sure that they continue to be aware of our issues and as any skill gaming legislation does come up, the easy way to address the distribution of the funding is simply to reference that any funding that goes to the local entities be distributed in accordance with the same formula used for all of the other gaming and gaming related items. And so we've put that language together and we will start distributing it. So, I think we'll be in good shape as this comes about.

But as Perry noted, this session is going to expire December 31<sup>st</sup>. It is unlikely that this legislation is going to be pushed, but we need to be ready in the event that something does happen.

Mr. Cleaver: When you say push, what do you mean by it?

Mr. Wachter: Legislation was entered into committee in May; it hasn't moved since then. It hasn't been addressed; the committee hasn't addressed it. It does not seem poised to be passed prior to the end of the legislative session. And the way that it works in Pennsylvania is anything that is not passed during one legislative session needs to get reintroduced into the next in order for it to have another opportunity to be adopted.

Mr. Oberlander: Are they looking at a potential loss if they, you know, from this gaming situation, from these skill games?

Mr. Wachter: I think they have. I know that the Governor made a big push to have skill game taxes put into the last budget, and that was not able to be moved there. And I know that a lot of municipalities are struggling. A lot of my municipal clients, the number one question I've been getting from them for the last three to four months is, "What do we do with these skill game parlors?" they call them, that are basically convenience stores loaded up with skill games. There's no staff, you can walk in and spend all your money on them. And how is that impacting the downtowns and a lot of our smaller rural communities? And so, we're trying to address it via zoning and other issues, but we have very limited tools, as we have the best laws that 1950 wrote that we're trying to apply to 2024 technology and so we're hoping that the taxes do come about. The local municipalities are hoping that

they do that in order to kind of limit their growth. They have to be taking a look at it. And I know that the casinos are very concerned about it as well, because it's impacting their take.

I have nothing further.

There is no Old Business to address.

#### **NEW BUSINESS**

a. Resolution Number 21, 2024 – Resolution to enter into agreements with six (6) entities that comprise the recipients of the 2024 Anchor Building Program

Dr. Wood reads the resolution.

Mr. Louis makes a motion to approve the resolution. Mr. Oberlander seconds the motion. There is no discussion of the resolution. Motion carries 6-0.

 Resolution Number 22, 2024 – Resolution to authorize the executive director and solicitor to enter into negotiations and execute a grant agreement with Gannon University for up to \$500,000 for the purpose of investment in the Institute for Health and Cybersecurity Knowledge (I-HACK)

Dr. Wood reads the resolution.

<u>Mr. Oberlander</u>: One question. When portions of this half a million dollars go out, do we vote on those specific portions or are we allowing one vote for the half million and you guys can decide on when it goes out?

<u>Dr. Wood</u>: I would say based on the way this is written it's a one-time vote.

Mr. Winschel: Perry, I know we had talked a lot about this at the Strategic Planning meeting – it's a half-million dollars. What are the conditions of that? Is that a match? Is that contingent on them raising so much? I know we had talked about a lot of different things, so when we you say negotiate and execute . . .

<u>Dr. Wood</u>: I would say it would be contingent upon them raising the \$6 million that they said that they would raise.

Mr. Winschel: Okay.

<u>Dr. Wood</u>: It would be contingent on – another Board member had asked about the Community Benefit results – quantifying those results as milestones. Sometimes in these resolutions we actually put the milestones right in the resolutions so it's clear as day. It would involve making sure that there is a timeline to report; and something like this where it's a multiyear we'll have interim reporting.

Mr. Winschel: So, the half a million you said will be based upon them raising the \$6 million; will that be set aside in an escrow account with us waiting for that and that triggers the event?

<u>Dr. Wood</u>: If you think about the Treasurer's Report, there is a Restricted Committed area for the funds so we would add \$500,000 to that line item. It might still physically be in the Money Market, but . . .

Mr. Winschel: I understand; it's just not disbursed.

<u>Dr. Wood</u>: Are there any other strong feelings about tenets to the contract?

<u>Mr. Wachter</u>: The only other thing I have thought of over the years and things that we need to be more clear about in our contracts is the time period in which this needs to occur so that if it doesn't occur within so many months or so many years that the award terminates on its own or is required to come back to the Board.

<u>Dr. Wood</u>: What's the feeling on that? One year? Two years? Eighteen months?

Mr. Wachter: I think it's project specific. I don't think any one policy could be called on that with this project; I don't know all the details, but it sounds like it will be a multi-year project to occur versus something else that could be done in six months.

<u>Dr. Wood</u>: They should be able to raise \$6 million in the next 18 months. So, we could put 18 months in the contract with the ability of the staff to extend it by six months.

Mr. Wachter: Raise within 18 months, six-month extension from staff for unforeseen circumstances, plus a full drawdown and spend within 24 months. I just want to be sure that whatever milestones are stated that it gets kicked back into your coffers.

Mr. Cleaver: Do we need a motion to add that to the resolution?

Mr. Wachter shakes his head no.

Mr. Barney makes a motion to approve the resolution with the updated timeframe language as discussed. Mr. Cleaver seconds the motion. There is no further discussion of the resolution. Motion carries 6-0.

 Resolution Number 23, 2024 – Resolution of the Erie County Gaming Revenue Authority approving ECGRA Investments into the Pennsylvania Local Government Investment Trust (PLGIT) pursuant to the ECGRA Investment Policy and prior Board authorization

Dr. Wood reads the resolution.

<u>Dr. Wood</u>: Once again, this just authorizes us to be a member of PLGIT so that in the future when CDs come mature, we can check PLGIT along with other institutions for the best investment.

Mr. Cleaver: When do we do that?

<u>Dr. Wood</u>: It's a ladder, so the next one would be up in two months. So, three months, six months, nine months, one year.

Mr. Winschel: And Whitey, if you will recall the discussion we had about the monthly financial reports, we will see those listed when they mature so that will give us time to talk about it. We can't go out and say hey, we can put this out another six months or year or something and take advantage of the opportunities.

<u>Dr. Wood</u>: I think it's worth noting too that PLGIT is a bank.

Mr. Winschel: Yes.

<u>Dr. Wood</u>: It's a municipal COG; it functions as a bank. They actually have banking services available to us as well so it's a possibility for us to look at in the future as we determine where we want to keep our primary banking.

Mr. Oberlander makes a motion to approve the resolution. Mr. Winschel seconds the motion. There is no further discussion on the resolution. Motion carries 6-0.

#### <u>ADJOURNMENT</u>

Mr. Barney moves to adjourn. Mr. Oberlander seconds the motion. Meeting is adjourned at 9:05am.

ERIE, PA (October 8, 2024) — Erie County Gaming Revenue Authority (ECGRA) announced \$34,000 of funding to support the purchase of a new ambulance for Harborcreek Township Emergency Response Team Program (HTERT), a multi-municipal collaboration between Brookside Fire Company, Fairfield Hose Company and Harborcreek Fire Department.

"ECGRA's multi-municipal collaborations grants were designed to support this type of outside-the-box problem solving by local leaders across Erie County," said ECGRA Executive Director Perry Wood. "The HTERT-237 collaboration is remarkable example of how municipalities can work together to solve challenges across geographic and political barriers to benefit their citizens. This investment is fundamental to providing emergency response capabilities for thousands of residents across the east-county."

ECGRA initially invested \$23,000 to support the purchase of the HTERT-237 ambulance in 2015. Since then, the crew has used the ambulance to respond to more than 2,200 calls.

"ECGRA funding has continuously been invested directly to our communities to help us make the major investments necessary to manage EMS needs of our citizens," said Dean Peppicello. "By working together, the HTERT has created a proven model to tackle the EMS crisis facing

communities across Pennsylvania. ECGRA funding helps us to continue supporting local volunteer fire departments by assisting in answering emergency calls when department volunteers are unavailable."

The HTERT team has responded to calls in Harborcreek Township and neighboring municipalities including Wesleyville Borough, Lawrence Park, North East and Greenfield Townships. The team responds to a variety of locations including single-family homes, apartment complexes, nursing homes and businesses. They are equipped to respond to structure fires, motor vehicle accidents, advanced life support situations, fall victims and basic patient assistance.

The Multi-Municipal Collaboration Grants were launched in 2012 to catalyze functional cooperation among Erie County's 38 municipalities and to support economic growth and vibrancy in the community. ## Emmaus looking Forward

Children out on boats in Lake Erie, on their first fishing trip, a narrow alleyway transformed into a garden, a walk-in freezer filled with donated food, light streaming through the windows of an art studio: in recent months, Emmaus Ministries brought each of these everyday miracles to life through the help of grants from several organizations.

Jane Wagner, Coordinator of Sister Gus' Kids Cafe, wanted to make this summer especially memorable for the dozens of children participating in the program throughout June and July. The Erie Community Foundation, specifically the William and Ethel Hovis Fund and the Hear Erie's Youth (H.E.Y.I) initiative, provided funding for field trips around the city, and for a special gardening project.

The field trips included a matinee at AMC Tinseltown, a day at the Erie Zoo, and an outing to Presque Isle with the SONS of Lake Erie, where the children went fishing and then spent the afternoon at the beach. "For a lot of the kids, those were brand-new experiences. They had never ridden the train at the Zoo, several had never seen a movie in the theater, and most had never been fishing. Even though the Peninsula is so close, it's difficult to get to, so several had never spent time at the beach before. They spent the whole time in the water and never wanted to come out," Jane said.

Meanwhile, at the Kids Cafe's home base on East toth Street, the children were tending a new garden beside the building. Funded by a grant from H.E.Y!, aimed at bullying prevention, the children planted and tended lettuce, tomatoes, beans, peppers, herbs, and broccoli. "If we can learn how to take care of plants, we can learn to take care of each other and encourage each others' growth," Jane said. They marked the end of the summer program by sharing a salad made with some of the garden's early produce.



Upstairs from the Kids Cafe, Saint Mary's Space to Create, a former Catholic grade school converted into artist studios several years ago, recently benefited from a major grant from Eric County Gaming Revenue Authority (ECGRA) which went toward renovating the facade and glass doors, and installing energy efficient windows. "It's a beautiful building, and it's important to keep it up, especially since it is full of kids and artists, who really appreciate beauty. Plus, the new windows reduced our energy usage by thirty percent, explained Emmaus Administrative Associate, Margaret Kloecker, who wrote the grant. She added that ECGRA has done a fantastic job of developing personal relationships in the community and working with us to make sure all our needs are met, not just for day-to-day operations, but for this kind of large scale improvement." Outdoor enthusiasts in Union City are now seeing a three-year plan for a trail extension become a reality.

On Friday, officials from the Erie County Department of Planning and Community Development, along with Erle County Executive Brenton Davis and officials from Union City Borough, the Oil Region Alliance and the Brie to Pittsburgh Trial joined together for a trafilead launch and groundbreaking at Caflisch/Deverseux parks at Bridge and Willow streets in Union City. The event included a ribbon cutting by Union

This groundbreaking will celebrate the trailhead installation and park improvements at Caflisch/Devereaux Park partially funded by a \$73,000 grant from the Eric County Greenways Program.

Davis said Brie County gave \$73,000 to its Parks Plan for infrastructure.

"The community development is every bit as important as economic development; they have to go hand-in-hand in order to attract good competition and good employees here and have a good quality of life," Davis said. "Parks and recreation play a vital role in choice communities."

The trailhead will serve Union City residents and begin to implement the Erie to Corry Trail Reasibility Study, published in 2023. The Erie to Corry Trail Fessibility Study was produced to extend the Erie to Pittsburgh Trail through Erie County, and this will be the first purphysebuilt trailhead for this extension. It will also serve the Prench Creek Trail as outlined in Union City's French Creek Trail as outlined in Union City's French Creek Trail

After trailhead launch was the pext step in the development of the Erie to Pittsburgh Trail and Prench Creek Trail, which is a critical regional project to develop the outdoor economy in Erie County.

feasica Horan, director of Eric County Planning and Community Development, said this trailhead really is the catalyst for two things—the

French Creek Trail, and, in a broader sense, a plan to develop the Corry to Erie segment of the Erie to Pittsburgh Trail.

"This serves as a trailhead to begin building 39 miles of trail," Horan said. "This will create an opportunity for those going to the Erie to Pittsburgh Trail to go on the Erie to Corry Trail.

"We developed the plan about a year ago and this is the first step in that development."

Union City Borough Manager Cindy Wells said it, was an exciting day for Uston City. She wanted to

thank the county, the Department of Conservation and Natural Resources and the Erie County Gaming Revenue Authority.

"I'm excited to see the project completed," Wells said. "It's been in the works a couple of years and it should be complete by mid-October.

"This is the completion of another phase of our Parks Comprehensive Plan and French Creek Trail Plan."

Union City's French Creek Trail Plan was published in 2022

The French Creek Trailhead at Caflisch/Devereaux parks is marked with a custom bike rack designed with chairs to showcase Union City as a historic town of furniture brettuction.

The proposed Eric to Corry Trail will connect Union City to a growing network of trails in northwest Pennsylvania and beyond. The Eric to Corry Trail Feasibility Study & Tourism Analysis (from 2023) Identifies a 39.5-mile trail route that traverses eight townships, two boroughs and two cities in Eric County.

Kim Harria, secretary for the Brie to Pittsburgh trall Alliance and outdoor program manager for the Oil Region Alliance, gave a history of the Brie to Pittsburgh Trail.

The Erie to Corry Trail creates a direct connection to the Erie to Pittsburgh Trail, a 270-mile trail that is nearly 70 percent complete. In addition to the Erie to Corry Trail, the Corry function Greenway Trail north of Corry is the other section of the Erie to Pittsburgh Trail that is in Erie County.

Mile zero of the Erie to Pittsburgh Trall is at Dobbin's Landing in Erie.

Also, the Erie to Pittsburgh Trail is a major corridor included in the Industrial Heartland Trails Coalition (HTTC). a vision to provide a L500 milesplus multiuse trail network experience across 51 counties in four states. Printsylvania, West Virginia, Ohio and New York.

# Local buildings to see improvements thanks to Mission Main Street

Various parts of downtown Corry will once again be receiving a facelift, thanks to the Erle County Gaming Rerense Authority's (ECGRA) Mission Main Street Grants.

Six local businesses and one church were recently notified by Impact Corry that they are this year's recipients. Cindy's Mane Event (4 E. Main St.). Creative Edge (6 E. Main St.). Equitable Advisors (16 S. Center St.). Winger Sultes and Williams Place (115-117 N. Canter St.). All Xunder Co. (36 E. South St.), the former Methof's building (40 N. Center St.) and Relevant Church (100 W. South St.). will each receive \$12,400 in matching funds for building façade renovations.

"The building owners come up with \$12,400 themselves, and the other \$12,400 comes from the grant," said Chuck Gray, executive director of impact Corry.

The program started in 2019 as administered through Impact Corry, but faced delays thee to Covid. Eighteen properties received matching funds from 2019 through 2023. While seven properties are funded in this cound, there are still 26 more on the waiting list.

"There have been two rounds of funding, but Covid pushed everything back," Gray said. "And some of the businesses that were approved didn't even know if they'd make it through Covid."

ECGRA launched Mission

Main Street in 2013 following studies which demonstrated that improving main streets can drive job creation and promote tourism — two critical economic growth components. With Mission Main Street Grants, ECGRA targets revitalization along countywide commercial corridors that are home to small businesses, historic structures and special events.

"Façade grants are essential," Gray noted "They change the perception of what the downtown is. They welcome people to walk into the stores, and once they stop in Corry stores, they come back."

Brenda Kirik of Williams Place is excited to get started on the renovations to the Winger Suites and Williams Place building.

"This is such an exciting adventure," Kirik said: "I am trying to learn all I can to make good choices. Of course my mind is racing with ideas and possibilities."

Kirik added she is looking furward to deciding on a culor scheme and possibly replacing windows and fake stones and removing a ledge left over from the previously removed covered walkways.

josh Dyne, owner of Dynasty Construction and some of the buildings in this year's grant funding, is also grateful for the grant.

"The Mission Main Street façade grants have been extremely helpful for us to improve our buildings, and have been a great tool to encourage small businesses to rent our spaces," Dyne said.

The tone church in the bunch—Relevant Church—is looking to make the front of it's building more inviting.

"The grant funding will go toward painting the building and making the front door approach more handicap accessible," said Jennifer Utegg of Relevant Church. Utegg said the church also has plans to resurface the parking lot, paint the sign pole and redo the sidewalks, although those projects will not fall under the grant guidelines.

Municipalities and nonprofit organizations with plans to renew historic commercial corridors can apply for Mission Main Street grants. A 1.1 cash match is required for all applicants. Projects may include overhauled streetscapes, revamped landscapes and restored facades.

Gray added Impact Corry is also exploring other granting agencies, including Keystone Communities and the United States Department of Agriculture (USDA). She admits those avenues are, "very competitive."

"The trend for funding is limited for façade renovation, so it takes a while," Gray said "But we are not giving up, and we are not slowing down. We continue to apply for those 26 on the walting list. And, there's a six-month turnaround from when we apply to when he we hear anything. We appreciate everyone's patience just as much as we appreciate the generous grants from Mission Main Street."

Dear Perry,

On September 21, 2023, Mercy Center for Women was awarded \$100,000 from ECGRA for renovations to the Mercy Center for Women's offices and residential facility.

The original scope of work was to upgrade an HVAC system, re-point the masonry, replace windows, and repair a parking lot. The total amount for that proposal was \$223,436 which was based on a grant of \$150,000.

As we prepared to reduce the scope of work from the original grant proposal to be inline with the grant award of \$100,000, our contractor discovered that the floor tiles in the area that housed our clients contained asbestos. For the long term safety of our employees, clients, and contractors, we arranged for the removal of the tiles immediately. The cost as completed was \$38,485. The parking lot repair was also completed in the amount of \$105,136.51. The total amount of work completed for this phase is \$143,621. The match for this phase was \$43,621 which is 30% of the project total.

The remaining work form the original scope of work will be completed between the end of 2024 and next spring.

We are requesting the addition of the asbestos removal for the current grant scope of work so we can closeout the grant.
